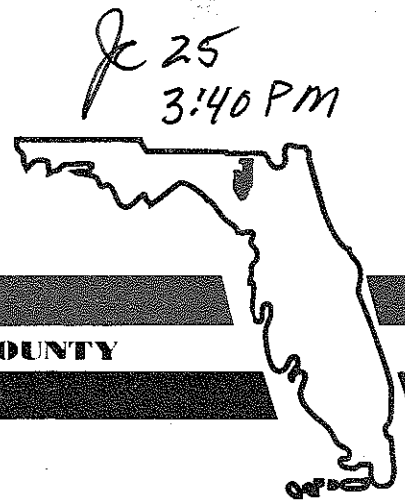

RE: Notice to Terminate Interlocal Agreement

Dear Mr. Chastain:

The Columbia County Board of County Commissioners, in regular session held February 19, 2009, approved Resolution Number 2009R-9 which provides for withdrawal from the consortium and Regional Workforce Board Interlocal Agreement effective June 30, 2009. The Resolution will not become effective until May 15, 2009, unless rescinded by action of the Board of County Commissioners prior to that date.

In accordance with paragraph 9 of the Interlocal Agreement any party may withdraw from the Interlocal Agreement by passing a resolution announcing its withdrawal and providing 30 days written notice to the other parties to the agreement. Attached you will find said Resolution as stated above providing for said withdrawal.

By copy of this letter, Workforce Florida, Inc., the Florida Crown Workforce Board Consortium and the Florida Crown Workforce Board will be notified of the above withdrawal.

As requested a meeting between the Columbia County Board of County Commissioners and the Florida Crown Workforce Board and Consortium will be scheduled. An available date for the Board of County Commissioners would be Thursday, April 9, 2009 commencing at 6:00 p.m. in the auditorium of the Columbia County School Board Administrative Complex. This meeting is contingent upon Florida Crown providing the requested public records and answers to specific questions. These have been requested under separate letter.
