**A RESOLUTION OF COLUMBIA COUNTY, FLORIDA,  
WITHDRAWING FROM THE CONSORTIUM  
AGREEMENT WITH THE FLORIDA CROWN  
WORKFORCE BOARD, INC. INTERLOCAL  
AGREEMENT.**

**WHEREAS**, Columbia County, Florida, as a member of the consortium of Columbia County, Dixie County, Gilchrist County and Union County, political subdivisions of the State of Florida, has previously entered into an Interlocal Agreement with the Florida Crown Workforce Board, Inc. dated December 6, 2007, for the purpose of establishing a Regional Workforce Board comprised of Columbia, Dixie, Gilchrist and Union Counties pursuant to *Federal Public Law 105-220, The Workforce Investment Act*, and the *State of Florida Workforce Innovation Act of 2000*, and for the purpose of establishing an integrated management and control structure for providing job training, job placement and related benefits services; and

**WHEREAS**, Columbia County has determined the Regional Workforce Board has been both ineffective and non-responsive to the employment and job needs of Columbia County, and it is, therefore, no longer in Columbia County's best interest to remain a member of the consortium or party to the Interlocal Agreement; and


**WHEREAS**, paragraph 9 of the Interlocal Agreement provides any party may withdraw from the Interlocal Agreement by passing a resolution announcing its withdrawal and providing 30-days written notice to the other parties to the agreement.

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF COLUMBIA COUNTY, FLORIDA** as follows:

1. Columbia County hereby withdraws from the consortium and Regional Workforce Board Interlocal Agreement effective June 30, 2009. Those members of the Regional Workforce Board appointed by Columbia County may continue to serve as members of the Board until their term expires, they resign, or are otherwise removed from the Board in accordance with procedures established by the Florida Crown Workforce Board.
2. This Resolution shall be effective May 15, 2009, unless rescinded by action of the Board of County Commissioners prior to that date.
3. In accordance with the Interlocal Agreement, notice of this resolution shall be provided to the other parties to the Interlocal Agreement, including Dixie County, Gilchrist County and Union County, and the Florida Crown Workforce, Inc.
